COURSE INFORMATION

WELCOME

Welcome to the SCO 220 Fundamentals and Application of SCO Operations course. This course meets the educational requirements of U.S. Security Cooperation Office (SCO) personnel and geographic combatant command (CCMD) staff personnel directly supporting SCOs. The course blends lectures, seminars, and practical exercises with instruction provided by Defense Security Cooperation University (DSCU) faculty members and guest lecturers, including senior DoD officials, representatives of other U.S. Government (USG) agencies, university professors, and members of private organizations.

In addition to lecturing and testing, learners are immersed in a cognitive learning environment where they leverage personal and professional tactics, techniques, and procedures to navigate through classroom interactive learning, computer simulations, and "real-world" situational events. Students will work with assigned, experienced faculty mentors in order to ask questions and exchange ideas on the concepts presented during the entire course. Mentors will assist the student in developing the art of applying the broad spectrum of tools, resources, and personal skills learned through the foundational phase.

Graduates will have the skills needed to effectively implement Security Cooperation (SC) aspects of U.S. foreign policy. Graduates will be able to crucially analyze, evaluate, and align U.S. SC interests and partner nation requirements.



COURSE GOAL

The goal of SCO 220 Fundamentals and Application of SCO Operations course is to educate SCO personnel and CCMD staff members to develop solutions to complex SC issues at the field level, given legislative and policy restrictions, stakeholder interests, and resource challenges.

COURSE OBJECTIVE

The objective of this course is for the student to creatively combine the art and science of SC in developing solutions to complex SC issues, while operating in the SCO environment, and given legislative and policy restrictions, stakeholder interests, and resource challenges.

By the end of this course the student will be able to:

- Interpret how to plan for, oversee, and execute the many complex and interrelated aspects of Security Cooperation and Security Assistance (SA)
- Evaluate and exhibit integrative knowledge, application, and synthesis of the core SC concepts, tools, considerations, and programs involved with Case execution and lifecycle management; SC planning, oversight, and execution; international student training, and SCO operations
- Measure strategic level guidance, evaluate the partner nation's (PN's) will and ability to achieve desired Security Cooperation objectives, create solutions, and propose courses of action (considering risks/assumptions) to align U.S. and PN strategic objectives
- Successfully navigate the Security Cooperation Organization Operational Environment
- Assess and reflect on the political, military, economic, social, informational, and infrastructural operational environment of an international region and/or country
- Simulate appropriate cross-cultural competence concepts during routine interactions with partner nations in the implementation of Security Cooperation initiatives
- Compose and defend recommended solutions to various stakeholders in order to solve SC issues, while aligning U.S. and partner nation interests
- Collaborate professionally, diplomatically, and influentially with defense industry contractors as well as within Combatant Commands (CCMDs), U.S. embassy country teams, and the broader DoD and U.S. government (USG) interagency communities
- Facilitate how to effectively develop, implement, and manage administrative, procedural, and personal/physical security programs of a Security Cooperation Organization



 Lead a role-playing scenario which demonstrates the analysis, assessment, and management techniques to administrate foreign training programs in order to support the formulation and execution of a country-level (U.S./Partner Nation) international training plan

By design, this course allows students to freely engage in real-world scenarios in a controlled learning environment where mistakes, which may have National Security implications, are made in the classroom and not on assignment.

ONLINE CO-REQUISITES

(Prior to arrival and during week one)

Three (3) supporting DSCU online courses are integral to the overall SCO 220 course. These courses are asynchronous, and students should endeavor to complete them before the inresidence portion of the course. These online courses are designed to meet the basic-level educational requirements of all workforce members, including those in the SCO Operations and Maintenance Area of Concentration (AoC). Due to the unique requirements associated with the assignment of personnel to SCOs in embassies around the world, students may not have the opportunity to achieve certification at the basic level before attending the SCO 220 intermediate-level course. Allowing time for students to fulfill both the basic and intermediate requirements while attending the resident course is thus an important factor in the development of this course.

The three online courses are:

- 1. SC-101 Introduction to Security Cooperation (12 hours)
- 2. ACQ 1300 Fundamentals of Technology (8 hours)
- 3. SC-121 Introduction to End Use Monitoring (2 hours)

SCO 220 COURSE NARRATIVE

The Security Cooperation Organization (SCO) is only one of many organizations within the United States Government (USG) and the Department of Defense (DoD) that contribute to the Security Cooperation (SC) and Security Assistance (SA) mission. However, the role of the SCO is unique in that it acts as the primary interface with the partner nation for most issues related to SC and DoD-administered SA.

As defined in DoD Directive 5132.03, SC should focus on three basic areas: creating access, building relationships, and creating or improving capabilities/capacities in partner nation security forces. The complexities of negotiating, planning, authorizing, funding, executing, and assessing these mission areas keep most SCOs intensely engaged, both with USG elements and partner nations. The SCO needs access to host nation counterparts to ensure USG objectives can be met. Central to this access are the SCO's relationships with the partner nation. In some cases, personal relationships are required before professional interactions are possible. Developing these crucial relationships takes time and patience—the Security Cooperation business is not an overnight enterprise. The SCO's fundamental task is to effect USG foreign policy and, in many cases, to build host nation capabilities and capacities to meet future USG and partner nation challenges.

The role of the SCO is complex, sophisticated, and critical to USG interests. SCOs must leverage and synthesize a vast array of skills. In this course we will use Bandaria as a fictitious (yet taken from real-world events) partner nation case study to examine and simulate how SCOs can leverage both art and science in approaching SC solutions to complicated issues at the field level.



PHASE NARRATIVES

The course consists of seven overarching phases. They are:

PHASE 2 - REGIONAL EXPERTISE

PHASE 3 - CASE LIFECYCLE MANAGEMENT

PHASE 4 - INTERNATIONAL TRAINING MANAGEMENT

PHASE 5 - PLANNING & PROGRAMS

PHASE 6 - SCO OPS/CAPSTONE PREP

PHASE 7 - CAPSTONE

Phase 1 (SC Strategy and Policy) Narrative

Security Cooperation is rooted in U.S. strategy and policy. In Phase 1, we'll examine what SC is and how SC furthers U.S. interests. You'll review the foundations and building blocks of SC and learn how Security Cooperation Organizations (SCOs) fit into the overall SC map of stakeholders. You'll hear from distinguished guest speakers on SCO perspectives from the field, and we'll lay out a vision of how SCOs can be successful in such an important role. You'll examine the importance of SC within the context of "strategic competition" and explore the importance of Women, Peace, and Security issues as SC continues to evolve.

Key High-Level Takeaways

The U.S. competitive advantage in the era of strategic competition is our network of allies and partners. The SCO has a critical role in the implementation of foreign policy and achieving U.S. security goals. SCO personnel must understand SC fundamentals and apply its building blocks to effectively further U.S. interests.

- What do we mean by Security Cooperation what is it?
- What does our nation hope to achieve through Security Cooperation?
- How might my partner nation appear in the context of strategic competition?
- How do law, policy, and stakeholders come together to shape, enable, and restrict the effectiveness of Security Cooperation?
- Who are my stakeholders?



Phase 2 (Regional Expertise) Narrative

Security Cooperation is about ensuring U.S. interests by maintaining strong relationships with our partners across the globe. In Phase 1, we looked at the basics of SC from a U.S. perspective. In Phase 2, you'll turn your attention to cultivating an understanding and a mutually beneficial relationship with your partner nation. You'll learn how to work more effectively in sensitive cross-cultural environments. Through a series of seminars led by guest speakers with regional expertise, you'll examine cultural, geographic, economic, historical, societal, and political characteristics within respective regions. You'll also examine U.S. regional strategic priorities and review how to make informed recommendations to various stakeholders.

Key High-Level Takeaways

SCOs should develop an understanding and appreciation of their partner nation and the region. SCOs must be able to build mutually beneficial relationships by engaging with effective cross-cultural skills. SCOs must also be able to make informed recommendations to U.S. stakeholders.

To Think about:

- How does my partner nation fit in the context of strategic competition?
- What personal and cultural dimensions do I need to consider to work most effectively with my partner nation?
- What cross-cultural skills do I need to be effective with my partner nation?
- How would I explain the SC strategy priorities for my partner nation and the region?

Phase 3 (Case Lifecycle Management) Narrative

SCOs serve as the primary SC liaison between the USG and our partners. In Phases 1 and 2 we looked at U.S. and partner nation interests through an SC lens. In Phase 3, you'll focus on the SCO's role in Foreign Military Sales (FMS) Case management for the duration of its lifecycle. An "FMS Case" is basically a government-to-government agreement on the transfer of defense articles and services. You'll learn how to assist and facilitate the management of an FMS Case for the duration of the Case Lifecycle (Pre-Case Development, Case Development, and Case Management and Closure).

Key High-Level Takeaways

The SCO serves as the intermediary between the USG Implementing Agency, the FMS Case manager, and the partner nation. They must be able to ensure that each case is both prepared and executed in accordance with USG interests and partner nation desires.



To Think about:

- How would I explain the FMS process to my partner nation? To the Embassy?
- What would I need to assist my partner nation to develop the most complete actionable Letter of Request (LOR) to prevent delays and misaligned expectations?
- How will I manage partner nation expectations of FMS timelines?
- What would I do if the system they are requesting is not the right fit for their requirements?
- How do I address a partner nation request for a capability I know they cannot adequately sustain?

Phase 4 (International Training Management) Narrative

The SCO coordinates and facilitates all military training conducted or contracted by DoD for the partner nation. In Phase 4, you'll focus on the SCO's role in being able to effectively manage U.S. education and training for our international partners. You will learn how to use and leverage various automated tools in the management of international education and training. You will also learn your role in vetting international students and how to advise them on travel preparation, English language requirements, etc. Additionally, you'll learn how to advise our partners on all aspects of international training management and how to develop and assess education and training plans for your Geographic Combatant Command.

Key High-Level Takeaways

The U.S. international military training program may be one of the most important Security Cooperation engagements the U.S. has with another country. The SCO must be able to effectively advise and assist the partner nation in identifying, forecasting, and programming training requirements of all kinds (e.g., professional military education, tactical training, technical skill training, etc.).

- How will I make sure my education and training plan supports the overall Security Cooperation strategy for my partner nation?
- How will I ensure the right people from my partner nation attend U.S. education and training?
- How can I help international students be successful in U.S. education and training?



- How do I communicate the vetting requirements to my partner nation?
- How will I advise my partner nation on U.S. education and training opportunities?

Phase 5 (Planning and Programs) Narrative

SCOs serve critical roles in contributing to SC planning and SC programs implementation. In Phase 5, we examine SC Planning and Programs. You'll learn about various SC programs, exercises, and the importance of Institutional Capacity Building (ICB). You will also learn to use various planning, analytical, and implementation tools, as well as review how to assess, monitor, and evaluate programs.

Key High-Level Takeaways

The SCO is the primary U.S. in-country SC interface with the partner nation. The SCO evaluates international partner requirements and contributes to plans to provide U.S. resources and other engagements necessary for the development and sustainment of partner capabilities consistent with U.S. interests. This assessment and preparation are critical in ensuring that U.S. planning, approvals, budgeting, production, and transportation processes can be sequenced and coordinated to effectively deliver capabilities.

- What is my role in SC planning with the Geographic Combatant Command? With the Embassy? Within the broad interagency?
- How will I reconcile U.S. interests in SC with my partner nation interests and seek alignment?
 - How will I explain partner nation interests to the USG?
 - How will I explain USG interests to my partner nation?
- How do I know if my SC activities will result/are resulting in the correct outcomes?
- How can I use multiple SC programs and activities to achieve a national strategic effect?



Phase 6 (SCO Ops/Capstone Prep) Narrative

SCOs must be self-reliant in managing or even directly resolving internal administrative and logistical support issues. In Phase 6, we turn our attention to SCO Operations and preparation for the course capstone. You'll learn to successfully navigate your operational environment, and what it takes to do so while maintaining and exhibiting important principles and attributes. You'll also learn, among other things, how to execute various administrative SCO responsibilities. Equally important, you will take a deep dive into your country team as well as begin learning to prepare and plan for various real-world emergency situations.

Key High-Level Takeaways

As SCOs are physically located in another country, it is critical that you understand your operational environment, how to navigate within it, and how to execute various administrative functions of the SCO. It is also critical that you understand and adhere to SCO ethics, exhibit successful SCO principles and attributes, and be prepared to plan for a wide variety of unforeseen situations.

- How will I interact and integrate into the U.S. Embassy, professionally, organizationally, and financially?
- Who do I need to know and connect with at the Geographic Combatant Command for administrative lifelines?
- How do I establish and maintain a cadence of communication between the SCO, the (Defense Attaché Officer (DAO), the Geographic Combatant Command J5, Office of the Secretary of Defense-Policy (OSD-P), and the partner nation? Who else needs to be in that loop?
- How do I make sure that I and those around me maintain our principles and act ethically in what can be an unstructured and ambiguous environment?
- How will I take care of my family?



Phase 7 (Capstone) Narrative

SCOs serve a critical role in furthering U.S. SC interests. The first six phases can be looked at as the science of SC, with some learning of how to apply the art of SC. In the final phase (7), within the context of real-world simulations, you will pull it all together and demonstrate how to successfully apply the art of Security Cooperation.


Key High-Level Takeaways

The role of the SCO is unique in that it acts as the primary SC interface with the partner nation. This role is pivotal in aligning the interests of the U.S. and our partners. This phase is your opportunity to develop a unique SCO skillset, as well as realize how an integrated SC Enterprise approach to problem-solving can effectively generate better solutions that benefit all stakeholders.

- What are my personal takeaways from this experience and what should be my personal "to think about" list as I transition to this assignment?
- How should I navigate my Security Cooperation Operational Environment?
- How can I maximize the tools of SC Science and SC Art to maximize strategic effect and improve my nation's security?
